NOTICE IS HEREBY GIVEN, for the public sale or auction of Municipally Owned Lands in the Borough of Bloomsbury no longer needed for public use as approved by Resolution #40-21; approved by the Borough Council on August 24, 2021, pursuant to and as set forth by the Local Lands and Buildings Law (N.J.S.A. 40A:12-1 et. seq.) with regard to the following property: Block 13, Lot 6.01, commonly referred to as "The Black Mill"

All bids for the aforesaid properties shall be submitted in a sealed envelope delivered to Lisa A. The following are conditions of the sale:

A. No minimum bid price shall be established; however, the Borough reserves the right to reject all bids where the highest bid is not accepted;

B. The building and land are to be conveyed by the Borough are in "as is/where is" condition and the successful bidder accepts the property with all faults;

C. The use of the property shall be related to a lawful public purpose and shall not be inconsistent by imposing a different standard than any zoning ordinance, building, plumbing electrical or similar code ordinance than in effect in the Borough;

D. The sale shall be subject to the successful bidder being obligated to obtain all third-party approvals of any other entity having jurisdiction over the use of the property;
